SUBJECT : Request for Evaluation and Approval of CCI Release Agent W60 under Item Number 414.2.1.2 Formworks Release Agents

This has reference to your letter dated April 10, 2025 (with attached documents) regarding the above-mentioned subject.

Please be informed that, pursuant to the DPWH Standard Specifications for Item 404 – Formworks and Falseworks, the requirement for formwork releasing agents is that they must be commercially manufactured. Accordingly, if the CCI Release Agent W60 satisfies this criterion, prior approval from this Bureau is no longer necessary. Any product/material that is already compliant with the existing DPWH Standard Specification can be utilized/adopted in DPWH infrastructure projects. Furthermore, this Bureau does not issue accreditation or grant permission for the commercial marketing of construction products.

Moreover, the selection of formwork release agents shall be at the discretion of the contractor, provided that the product complies with the specifications and requirements set forth by the Department for use in DPWH infrastructure projects.
